Christie declares emergency with 🕬 snow expected

With up to 6 inches of snow forecast to blanket North Jersey today and even more in areas to the south, Governor Christie placed all of New Jersey under a state of emergency on Wednesday night. The storm "is expected to pro-

duce travel hazards and potentialthe state," Christie said, asking drivers to "remain off the roads if possible so that our first responders and public safety officials can safely respond to any emergency situa-

However, Joe Pollina, a National Weather Service meteorologist, said the amount and type of snow in the forecast was "not typically what would cause widespread power outages."

Public Service Electric and Gas, the major utility serving North Jersey, said it was prepared for the storm, but added, is was not expecting widespread outages. The utility said it had additional workers and equipment on hand to deal with any emergencies and was also arranging for additional crews to take care of trees or limbs that fall across power lines.

The snow was expected to "start out heavy, but turn into a lighter consistency as temperatures fall through the night" and into today, Pollina said.

The forecast said that what was to begin as rain and sleet late Wednesday night would turn into snow and sleet and finally snow afly cause power outages throughout ter 2 a.m., with a total overnight snow and sleet accumulation of up to 3 inches before the morning rush hour.

Snow was forecast to continue through 2 p.m. today, with additional accumulation of 2 to 4 inches, the weather service said, adding that there was a chance of more snow before 8 p.m. and temperatures falling back into the frigid zone with a low of 9 tonight.

But the weather service had some good news for North Jerseyans. Starting on Friday, expect sunny skies with a high near 26, and that's just the beginning of a warming trend that should see temperatures rise to the mid-30s on Saturday, near 40 on Sunday and the mid-40s on Monday.

The warming trend is expected to continue through next week, the weather service said, coming close The weather service issued a to 50 by Wednesday. But don't put away your winter gear yet.



Central Jersey is bracing for one last winter wallop on Thursday

CENTRAL JERSEY - Gov. Chris Christie has declared a state of emergency, authorizing the state director of emergency management to activate and coordinate the preparation, response and recovery efforts for the storm with all county and municipal emergency operations

Update: State offices are closed today.

"Tonight's storm is expected to produce travel hazards and potentially cause power outages throughout the state." Christie said. "I've authorized state officials to take all necessary action to prepare, and my Administration will continue monitoring conditions throughout the remainder of the storm. I encourage all New Jerseyans to drive carefully and remain off the roads if possible so that our first responders

and public safety officials can safely respond to any emergency situations."

Next Wednesday, skies are forecast to be sunny with temperatures near 50 degrees.

But winter is poised to deliver a parting shot to Central Jersey with 4 to 8 inches of snow expected to fall from about midnight Wednesday to mid-afternoon on Thursday, according to the

Though temperatures reached in the relative balmy low 40s on Wednesday afternoon, an Arctic cold front was expected to slice across the area Wednesday evening, setting the stage for minor areas of low pressure to ripple along the front and bring the snow into the colder air.

The timing and path of the low-pressure systems will determine how much snow will fall here. Computer forecasts are calling for about five inches in Central Jersey, with higher amounts south of Route 195 and lower amounts north of Route 80.

Temperatures are expected to drop from 35 degrees at around 11 p.m. Wednesday to 23 degrees at 11 a.m. Thursday. Winds are expected to increase on Thursday, with wind chills dropping to zero.

Forecasters believe this could be the last Arctic blast of the winter before spring arrives on March 20.

Temperatures are expected to remain the 20s on Friday before reaching the 30s over the weekend and the 40s early next week.

Tonight's storm is expected to continue through Thursday, bring heavy snow, mixed precipitation including ice, and freezing temperatures throughout the State. The forecast for snow has already prompted a number of cancellations and delayed openings for Thursday.

The snow may play havoc with public schools, many of which are in the middle of the state's new PARCC testing.

To give customers more travel options, NJ Transit is offering full systemwide cross-honoring on Thursday, enabling customers to use their ticket or pass on an alternate travel mode --- rail, light rail or bus - including private bus carriers.

All Somerset County senior centers will be closed on Thursday. There will be No Meals on Wheels deliveries.

In New Brunswick the parking decks opened at 6 p.m. Wednesday for residents to park their vehicles off city streets. A Code Blue in effect in New Brunswick through Friday.

The Perth Amboy Parking Deck at 151 Jefferson St. is closed due to a power outage. The deck will not be available for parking during the storm. Residents can park at the train station lot.

Union County has declared a 10 a.m. delayed opening for nonessential county employees. The Union County Courthouse will open at 10 a.m.

The Theatre at Raritan Valley Community College's presentation of The Jammin' Divas, originally scheduled for Thursday with performances at noon and 7 p.m., has been postponed. A new date will be announced.

Edison, Spotswood and North Brunswick have canceled garbage and recycling pickup on Thursday.
